- Sponsors get listed as such on our website, with a link to their website. They also get listed as sponsors in our Program, with their website.
- Booth locations are assigned first to sponsors in the order that applications are received, then to non-sponsors in order that applications are received.
- Items that may be sold at the Vista Fiber Arts Fiesta include fiber related and hand crafted items. No animals may be sold.
- Vendors must have a valid copy of their seller's permit in their booth at all times. A current seller's permit is required for anyone selling any item. You are responsible for collecting your sales tax.
- Booth spaces are 12' x 12'. All vendors must stay within size restrictions and may not infringe on walkways, fire lanes or neighboring booths. Booth spaces will be held only with payment of fees.
- Vendors and exhibitors are limited to two spaces.
- Space fees: Vendor is \$75.00 for the two day event. Sponsor is \$100.
- Space can be used to sell wares, do demonstrations, promote your group or all of the above.
- There are no refunds after September 1, 2018. This event will take place rain or shine.
- Application deadline is two weeks before the start of the event (September 20, 2018). However, space is limited. If you wait, you may not get a space. Once the show is sold out, there are few cancellations.
- All sales transactions are between the buyer and the seller. AGSEM and the Vista Fiber Arts Fiesta have no interest in such transactions and are in no way responsible.
- Vendors must provide their own tables, chairs and awnings, if needed.
- All booths must be set up by 10:00 am each day of the show. Vendors may setup awnings, tables and chairs beginning at noon on Friday, October 5, 2018.
- There is no parking on the fiesta grounds; you must finish unloading and return your vehicle to the parking lot by 9:30am. If handicap parking is needed, contact the museum office and a parking pass will be issued.
- Security: the front gate of the Museum is locked at night. There is no other security. Goods left at your booth overnight are left at your discretion. AGSEM and the Vista Fiber Arts Fiesta are not responsible for them.
- You may not transfer your space to any other persons not named on this agreement without prior approval of the Vista Fiber Arts Fiesta. You may share your space with another group or vendor.
- No animals (no dogs except service dogs) or alcoholic beverages are allowed on the Fiesta grounds.
- Dry camping facilities are available on the grounds. They are free for sponsors, exhibitors and vendors or \$10.00 a night for others. Pets are only allowed in the campground, not on the Fiesta grounds.
- If you wish to bring animals as part of your display, please contact the Fiber Arts Fiesta organizers.
- Please include with this application a description of items to be sold. Also include pictures or brochure if available.
- The Vista Fiber Arts Fiesta reserves the right to deny any application due to duplication, appropriateness, etc.
- All articles offered for sale or sold must be removed from the grounds at the close of the show. Articles left on the grounds after the show shall become property of the Museum and may be disposed of with the proceeds going to the Antique Gas & Steam Engine Museum.
- Other events are taking place at the Museum the same weekend: The Watch and Clock Collectors Mini Mart and the Vista Gem & Mineral Society Show. The Blacksmith & Wheelwright Shop is open as well as the Short Track Railroad exhibit.
- Admission to the events are free; parking is \$5 per vehicle. Exhibitors do not have to pay for parking.
- Food will be for sale at the Food Court.
